



12 AND 15 PASSENGER VAN SAFETY ADVISORY

REDUCE YOUR CHANCE OF ROLLOVER

12 and 15-passenger vans handle differently from other vehicles such as passenger cars. They do not respond as well to abrupt turns and require additional braking distance. It is critical that both drivers and passengers follow some simple safety rules to minimize risks to themselves and their loved ones.

Check your safety belts

- ✓ Drivers are required to ensure all occupants wear safety belts at all times.

Check your tires

- ✓ Inspect the tires before every trip. Check that the van's tires are properly inflated. Make sure there are no cuts in the tire's sidewalls and that the treads are not worn down.

Check your vehicle loading

- ✓ A significant increase in rollover risk occurs when 12 and 15-passenger vans are fully loaded with drivers and passengers.
- ✓ If possible, have passengers and cargo forward of the rear axle and never place any loads on the roof.

Check your road conditions

- ✓ Maintain a safe speed for weather and road conditions. Most rollovers occur at high speeds as a result of sudden steering maneuvers.
- ✓ A 12 or 15-passenger van is much longer and wider than a car and requires more space to maneuver. The width of these vans allow for less lane room.
- ✓ They also require additional reliance on the side-view mirrors for changing lanes.
- ✓ The length of the vans also increases distance needed for making turns, changing lanes, and braking.

Check yourself, the driver

- ✓ U.S. DOT recommends passenger vans be driven by experienced and /or trained drivers.
